- a. Approved the proposed amendment to the Constitution of Trevecca Nazarene University submitted by the Trevecca Board of Trustees.
- b. Upon receiving notice of the resignation of Dr. Robert Yates as a newly elected member of the District Advisory Board, elected Rev. Jeanne Morgan to serve a three-year term as DAB member.
- c. Designated the following District Officers: District Secretary—Rev. Steve Egidio; District Treasurer—Mindy Rickey; DAB Secretary—Charles Davis.
- d. Designated the following as members of the District Finance Review Committee: Brent Williams (Chair), Charles Davis, Dale Schaeffer, Mark Patrick. Delegated to the District Superintendent the authority to appoint persons to fill vacancies on this committee.

  - 2. Approved the request of the New Port Richey First Church of the Nazarene to refinance its existing indebtedness and a grant to the church to assist in structural repairs of the facility.

- 3. Approved the request of the Brooksville First Church of the Nazarene to lease a storefront for use as a Thrift Store and worship facility and to loan the funds needed to execute the lease.
- 4. Approved the following name changes: Brooksville First Church of the Nazarene to Brooksville Bridge Fellowship Church, Tavares to Tavares One Foundation,
- 5. Approved the sale of two houses owned by the St. Petersburg Victory church with the proceeds to reduce the mortgage indebtedness.
- 6. Approved the request to designate Orlando Way to Calvary Church as a 10% Mission Special status
- n. Approved the implementation of the suggestions from the Board of General Superintendents regarding the cancelling of the 2020 District Advance. The proposal provides that:
  - 1. The term of all District elected positions that are scheduled to be filled by election at the Advance would be extended for 1 year.
  - 2. The delegates to the 2021 General Assembly would be elected by the District Advisory Committee.
  - 3. The District Advisory Committee would approve the ballots prepared for the election of delegates to the 2021 Global Ministry Conventions.
    - 4. The District NYI Council shall elect the delegates to the 2021 Global NYI Convention.
    - 5. The District NMI Council shall elect the delegates to the 2021 Global NMI Convention.
    - 6. The District SDMI Council shall elect the delegates to the 2021 Global SDMI Convention.
    - 7. The District Advisory Committee will transact all other business items normally transacted by the delegates at the Advance.

It has been a joy for the board to work with our wonderful leader and shepherd over the past year. We have quickly come to appreciate the insight and leadership our new District Superintendent is providing in his new assignment. His commitment to building God's kingdom is inspiring and we are grateful that God, in His providence, has brought Rev. Schaeffer to be our District Pastor.
